The purpose of the Fall Product Sale Activity is to teach girls to work as a team, set goals and strive to achieve them, handle and account for money, and develop sales and marketing skills. The money earned supports troop activities and other activity services and opportunities throughout Girl Scouts of Gateway Council.

Girl Scouts of Gateway Council will be participating in the 2009 Fall Product Sale Activity in 3 ways:

- By selling Ashdon Farms nuts and candy to family and friends each Girl Scout will earn proceeds for her troop and earn cumulative incentives for herself based on her sales.
- By completing a QSP Step 2 address book with 10 addresses each girl will receive a patch and earn \$2 in proceeds for her troop. Sisters must have 10 different addresses.
- ♦ By participating in the QSP online activity. Troop receives \$2 in proceeds for her troop for every magazine order recorded on the "Detailed Order Report" turned in to troop by Oct. 15, 2009. Girl will receive a patch for sending 12 emails, a Super Seller patch for 10 subscriptions, and credit for each subscription towards her cumulative incentives.

Girls will also be able to participate in the QSP **Be A Reader** and **Address Adventures** with their troop. (Patches are purchased through the Council shop).

Order taking begins on September 11, 2009 and ends October 11, 2009.

Nuts and Candy will be delivered to troops the week of November 16, 2009.

All money is due to the troop no later than December 7, 2009 or date given to you by your troop.

Please read the information below before signing permission form.

- I understand that orders may not be taken, in any form, before September 11, 2009.
- I understand that I must provide adult supervision of my Girl Scout's participation in the product sale activity at all times.
- I understand that the following information must be on all checks taken in payment:
 - *Check must be made payable to Girl Scouts of Gateway Council, Inc.
 - *Check must be pre-printed with the customer's name, address, and phone number. Accept checks drawn on local banks only.
 - *Customer's driver's license number, state, **sex, race** and date of birth must be written on the front of the check by the girl or parent/guardian.
 - *Troop /group number, first name and last initial of the Girl Scout must be written on the memo line of each check accepted.
- I agree to accept responsibility for all nuts/candy and money my Girl Scout receives and to assist her in making prompt deliveries and payments for nuts/candy entrusted to her. I understand that monies collected by my Girl Scout belong to the Girl Scouts of Gateway Council. In the event of non-payment for the nuts/candy received, I understand that Girl Scouts of Gateway Council, Inc. reserves the right to initiate collection procedures by its designated agent, including civil suit and criminal prosecution on accounts delinquent after December 7, 2009. I further understand that all costs associated with the above mentioned collection process, including collection and/or attorney fees incurred, will be my responsibility. I also understand that nuts/candy received may NOT be returned.
